1. The Republic of Azerbaijan has received financing proceeds from the Islamic Development Bank (IDB) towards the cost of implementing the National Water Supply and Sanitation Project in 6 regions. It is intended that part of the proceeds will be applied to eligible payments under the contract for the Design, Supply and Installation of Wastewater Treatment Plants in 3 Cities.
2. The Azersu Open Joint Stock Company now invites sealed bids from eligible bidders for Design, Supply and Installation of Wastewater Treatment Plants in 3 Cities consisting of, but not limited to, the followings:

### Waste Water Treatment Plant

- a) Design, Supply and Installation of WWTP in Gadabay city with a productivity of at 3 500 m<sup>3</sup>/d;
  - b) Design, Supply and Installation of WWTP in Tertar city with a productivity of at 7 500 m<sup>3</sup>/d;
  - c) Design, Supply and Installation of WWTP in Kazakh city with a productivity of at 10 000 m<sup>3</sup>/d;

Dear Mr. Etibar Mammadov,

With reference to the email from AzerSu sent on 2 June 2017 and after careful and several reviews of the Invitation for Bid for the Wastewater Treatment Package (Gadabey, Terter and Gazakh) for the above mentioned project, the IDB is giving No Objection to proceed with the finalization and publication of the Invitation for Bid subject to the following conditions being fulfilled by AzerSu:

- 1) The time interval between the Bid Invitation and the Bid Submission should not be less than 90 days since this is an Open International Bidding (Clause 2.34 guidelines for procurement of Works, May 2009) but also to take into account, in the case of Gadabey bidding, the fact that several applicants cancel their participation due to the fact that the bidding documents were received too late.
- 2) The Invitation for Bidding shall be published in an International Newspaper available in several countries (example The Economist or ASHARQ AL-AWSAT), in a local newspapers at least twice on two none consecutive days within a span of ten (10) days and, in all the consulate or embassies of the IDB members countries in Baku. These advertisement guidelines should be followed strictly.
